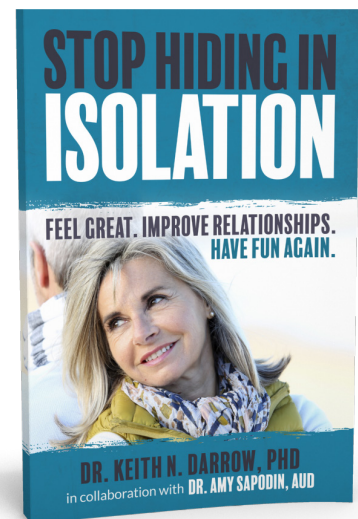

1 Step Sign Up Early!

Perhaps you already follow the “5 P’s to Success,” (Proper Planning Prevents Poor Performance!) but in case you don’t, this is one thing you want to plan early for so you can maximize the benefit. Many employees set higher limits than you think on the amount of flexible spending dollars you can contribute and access.

I have seen employees with as much as \$2,500.00 and some with even \$5,000.00 in flex-spending dollars available to them. Failure to sign up early could cost you more in out-of-pocket medical expenses, especially if your plan is not up and ready before you or a loved one needs to treat his or her hearing loss. If you have a new plan, work with your human resource contact to sign up early for next year in order to maximize your savings.

2 Step Notify Your Employer of Family Status Change.

Different employers have different sign-up deadlines for the flexible spending plans, but typically at the beginning of the year your employer asks how much money you want to contribute for the year.

The problem with making annual decisions about health care coverage is obvious—life happens and sometimes it’s nearly impossible to plan ahead that far! You may apply for a Family Status Change for changes such as marriage, birth, divorce, or loss of a spouse’s insurance. These are opportunities to add more coverage for hearing loss treatment expenses.

3 Step Choose Wisely!

Finally, give some thought to calculating how much money to contribute to your flexible plan at work this year and every year. If you are considering hearing loss treatment for you or a family member, visit your local Excellence In Audiology member-clinic to learn about **TreatmentFi™** during initial consultation.

Your patient care coordinator(s) can help you plan exactly how much money you should contribute to help reduce your out-of-pocket costs when it is time to pay for and receive your NeuroTechnology™.

4 Step Use It or Lose It.

Here’s something you may not know (and frankly, has always puzzled me!): if you put more money into your flex spending account than you need or use, by law, you lose the money! Yikes!

BUT...you have three months after the end of the calendar year to submit claims for eligible medical expenses from the previous calendar year. Any money left in your account after this three-month period is forfeited.

TreatmentFi™ and Insurance Benefits

While many patients in America do not have **'the treatment of hearing loss'** as a covered benefit, some people do. As an example, there are several states that have a mandated benefit for state employees; there are even certain federal employees (i.e. postal workers) that have a set benefit that can be used once every certain number of years. One thing for sure, is that an insurance plan that will cover the ***total*** cost of treatment is like 'winning the lottery' and a very rare find. Thus, ultimately, even with insurance the patient will most often still have an out-of-pocket cost. Attempting to determine which health insurance programs do and do not offer a benefit is an insurmountable task, especially considering the constant changes to health insurance programs.

For those few who do have insurance benefits that will contribute to the cost of treatment and hearing devices, the good news is that you can combine your benefit with a **TreatmentFi™** subscription program to even further reduce your low fixed monthly payment. If your local Excellence In Audiology member-clinic accepts the benefit provided by your insurance plan, they can easily integrate the benefit; thus, adjusting your subscription plan to a lower monthly cost.

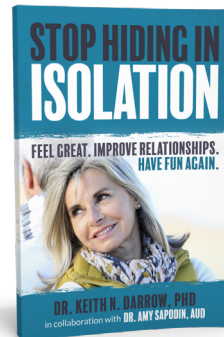
